OPTIMIZE warrants that **OPTY-COIL coatings** are manufactured free from defect and will perform in accordance with its published product specifications, for a period of five (5) years, from the date of product installation against general failure of the product when applied properly by trained Installers and in accordance with the specific products intended use. Failure is defined as delaminating or loss of adhesion from the substrate on the coil face in an area of **25%** or greater of the surface area. Normal abrasive wear or superficial scratching of the **OPTY-COIL Coating** treatment does not constitute a failure and is not covered under the terms of this Limited Warranty. **OPTIMIZE** will decide at its discretion to provide coating product either to recoat an existing coil or a replacement coil, purchased by the owner. **OPTIMIZE** warrants the performance of its coil coating product and will not pay for cost to purchase or replace a coil.

OPTIMIZE does not and will not warranty the installation process or quality of installation. The installers shall be liable for their own installations and will warrant their installation work.

The sole obligation of **OPTIMIZE**, under this Limited Warranty shall be to replace any portion of the **OPTY-COIL Coating** proven defective, not to exceed the quantity of product from the original installation. Proof of purchase is required.

This Limited Warranty does not cover damage due to misuse, accidents, neglect, intentional abuse, improper maintenance, lack of factory suggested maintenance, wind driven sand or erosion, acts of war, acts of vandalism, or acts of nature. This Limited Warranty does not cover damage resulting from product installations or exposures for which the product is not intended and for causes outside of the control of **OPTIMIZE**.

This warranty does not cover the cost of a replacement coil, tools materials, labor, travel cost, crane cost, refrigerant, down time, freight cost, temporary equipment rental, equipment replacement or loss of use

This Limited Warranty is invalid if **OPTIMIZE** published cleaning procedures are not followed; including the use of non-specified surface cleaning chemicals or incorrect post maintenance cleaning procedures. **Acid or high base cleaners are not to be used and will void the warranty.**

The warranty is issued only to the **coil/equipment supplier**, not the end user. End user must follow factory cleaning procedures **quarterly** and supply records to **Optimize**, upon request of any claim against the warranty.

End user shall not use acid based or high base type cleaners. End user shall not use a pressure washer to clean coils. Mild, non corrosive detergents and water with standard garden hose pressure are acceptable.

The Limited Warranty, described herein, shall be in lieu of any other warranty, express or implied, including, but not limited to the implied warranty of merchantability and fitness for a particular purpose. The purchaser shall determine the suitability of the product for his/her intended use and assumes all risks and liabilities in connection with said suitability of product for a particular use or purpose. This Limited Warranty extends to the original purchaser of the **Optimize** product, only and is not transferable.

In the event of any failure of product covered under this Limited Warranty, the purchaser must notify **Optimize**, in writing, at 118 Rochester Drive, Louisville, KY, 40214, within 30 days of discovery of any defect of the product. Failure to notify **Optimize**, in writing and within 30 days of any noticed defect, shall nullify this Limited Warranty. The purchaser must also submit a copy of the receipt of purchase for product to **Optimize**, detailing the quantity of **Optimize** used. **Optimize System**, or its assigned agent reserves the right to field inspect any product installation covered under this Limited Warranty and preliminary to settling any customer complaint.

This Limited Warranty gives you specific limited legal rights and you may also have other rights, which vary from state to state.
